

**Fat Bottom Brewing Co.'s Fat Bottom Futbol Contests
Official Rules**

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. MUST BE 21+ TO ENTER.

1. Eligibility: Fat Bottom Futbol (#fatbottomfutbol) winners only open to legal residents of the fifty (50) United States and the District of Columbia who are at least twenty-one (21) years old at the time of entry. Contesting is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules, which are final and binding in all matters related to the season contesting. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. How to enter: There are two ways to enter to win prizes during the Fat Bottom Futbol contesting period:

2. Engage with @fatbottombrews & #fatbottomfutbol on Instagram (the Instagram specific contests entry rules will vary with each giveaway)

4. Prizes:

- One (1) VIP away game experience - away game location TBD, airfare up to \$1000, hotel accommodations up to \$300/night (two (2) night max), two (2) tickets to away game (TBD game location), \$200 prepaid Visa gift card
- One (1) Beer for a Year - One (1) lucky winner will win one (1) six pack per month (12 six packs total for the year) of brewer's choice Fat Bottom beer
- One (1) Away Game Viewing Party Experience - away game viewing party (game day date TBD) for 8-10 people with food and beverage included for the guests. Game (TBD on date) to be streamed on projector in the private dining area of Fat Bottom's West Nashville location.
- Five (5) winners per Nashville SC home game will win a pair of tickets to the game, gift cards and/or Fat Bottom merchandise (\$50 value per Fat Bottom gift card)

For all prizes: Terms and Conditions of game tickets and gift cards apply. For grand prizes: Terms and Conditions of the airfare, accommodations, gift card and private event space apply. Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winner is responsible for all taxes and fees associated with prize receipt and/or use. Odds of winning a prize depend on the number of eligible entries received during the Promotion Period.

5. Timing: Instagram, email sign-up and text to win contests begin February 20, 2020 and run until Saturday, September 26, 2020. Home game tickets, gift cards and merchandise winners will be randomly selected weekly through the Nashville SC season. Grand prize winners will be randomly selected on August 28, 2020 (VIP Away Game Experience), September 25, 2020 (Beer for a Year) and TBD (Away Game Viewing Party Experience).

7. Release: By receipt of any prize, each winner agrees to release and hold harmless Sponsor and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the contests or receipt or use or misuse of any prize.

8. General Conditions: Sponsor reserves the right to cancel, suspend and/or modify the contests, or any part of them, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the contests, as determined by Sponsor in its sole discretion. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the contests or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the contests may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the contests; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the contests; (4) technical or human error which may occur in the administration of the contests or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the contests or receipt or use or misuse of any

prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, not received, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the contests, if it is possible. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the contests, shall be governed by, and construed in accordance with, the laws of the State of Tennessee without giving effect to any choice of law or conflict of law rules (whether of the State of Tennessee or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Tennessee.
